Negotiations Updates

We've been talking about giving some crown land to Ngāti Ruapani mai Waikaremoana. We have two ways to do this: one way is to give the land directly to them right away, and the other way is to give it to the Te Urewera Board, who will manage it and let them use it when needed. Both ways let us use the land for building and other projects. We are thinking about different rules and laws, how the land looks, what we need to develop it, and conservation rules.

What's Next?

Before our next meeting in August, we will look at the land to see which parts we can develop.
