Settlement Milestone process

- There are 6 stages in the settlement.
- The Negotiations are completed for the first two stages
 - Deed of Mandate
 - Term of Negotiation.
- Currently the Negotiations are in the Agreement in Principle stage.
- The next stages are
 - Deed of Settlement
 - Ratification
 - Legislation

Claimant Funding

- The Crown contribution to wards costs of Claimant group for the Treaty Negotiations are called Claimant Funding.
- This is only a contribution and not reimbursement of full costs.
- On 18th Nov 2019, Hon Andrew Little has emailed letter disclosing Claimant funding upper limit for the historical Treaty of Waitangi claims of Ngati Ruapani ki Waikaremoana.
- Total of \$750,000 was set aside and is to be allocated at various Milestones/stages.
